DFK History

1960s

DFK Founders meet at the *Cercle de l'Union Interalliée* in Paris in 1962 to establish an international organisation aimed at bringing together like-minded professionals to serve clients with cross-border interests.



1970s

Coverage expands to cover most major economies in the world. The group adopted the name **Douglass F.M. Richard Kidsons**, recognising the central role of the founders.



1980s

DFK International established as a Dutch Vereniging with its executive office in London, moving to Russell Square in 1989. By this time, DFK had members in more than 50 countries worldwide with small independent firms joining, as well as larger national groups of multiple firms in the larger countries coverage.

1990s



The decade sees huge growth to more than 145 member firms in 69 countries. Members meet at amazing destinations around the world to exchange ideas and best-practice at national, regional and global conferences.

2000s

As we celebrated our 50th anniversary, DFK members and the executive office, continued to embrace technology to increase the efficiency of client support, with many adopting cloud solutions such as Xero and Office 365.

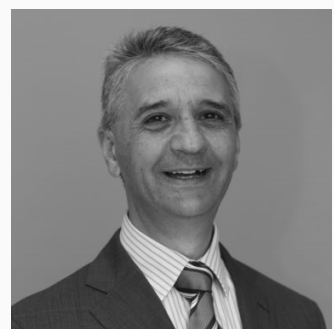
Vice-President EMEA
