The Greater Bay Area, China Dorothy Wong and Kelvin Or, JCK & Associations / JCK CPA

The Greater Bay Area (GBA) in China is an economic development plan aimed to develop a world-class cluster of 11 cities in the Pearl River Delta boasting a GDP of almost US\$ 2,000 billion (11% of China national GDP), 86 million people and a size of 56,000 sq km. In the presentation, Dorothy and Kelvin will introduce the key aspects that make the GBA an attractive destination for businesses ranging from small startups to established MNCs who are looking to expand their operations or tap into new markets.

When is a US Listing the Right Choice for Asian Issuers? Drew Bernstein, Co-Chairman, Marcum Asia

For the right company, an IPO on the US stock markets may provide a superior valuation and greater liquidity than listing on the local exchange. But that potential needs to be balanced against the greater legal and accounting complexity of a US listing, as well as the demands on senior management to cultivate shareholders on the other side of the world.

Drew Bernstein, whose firm is a leader in audits for Asian issuers listing in the US, will provide a detailed view of current trends in the US markets and the most important factors for companies and their advisors to consider in choosing the right listing venue.
